## RESPONSIBILITY WAIVER FORM

- 1) No person under the age of **10 years** shall ride in or on any portion of a chuckwagon or chariot which is involved in an All-Pro Canadian Chuckwagon & chariot Association sanctioned event. This applies to all times and situations within the event, as long as the event shall last.
- 2) Persons who are from **10 years to 16 years** must have this form signed and submitted prior to riding in or on either wagons or chariots at any All-Pro Canadian Chuckwagon & Chariot Association sanctioned event.
- 3) By signing this form the parent(s) or legal guardian for these riders assure that they are solely responsible for the welfare of this person, and that under no circumstances will the All-Pro Canadian Chuckwagon & Chariot Association be held responsible for injury or death of the rider or damage to the property of the rider, in the case of a mishap or accident.
- 4) In addition to clause 3 above, the undersigned further agrees that under no circumstances will any legal charges be filed against the All-Pro Canadian Chuckwagon & Chariot Association, should the rider be involved in an accident, even if it is believed that the accident was partially or wholly caused by action or in-action of the association or the executive of the association.
- 5) By signing below it is understood that this form also prohibits the undersigned from seeking any type of restitution, or charges through the legal system from the executive and/or members at large if the rider sustains injury or death, caused by an accident or mishap while riding in or on a wagon or chariot. (Executive and members are considered to be "the association").
